Green Timber Consulting Foresters, Inc. Agrees To:

1. Maintain certification in accordance with the American Tree Farm System, Group Certification Process and adhere to all American Forest Foundation Standards.
2. Provide a one year subscription to *TREE FARMER: THE PRACTICAL GUIDE TO SUSTAINABLE FORESTRY*. The only national magazine specially designed for forest landowners – full of articles with easy-to use information, product reviews and plans you can put to work right away on your Tree Farm.
3. Provide at least 1 newsletter per year.

4. Notify Green timber Consulting Foresters, Inc. if/when ownership status is changed or acres added or subtracted from the Tree Farm.
5. Pay annual dues of \$50.00 per year.
